Title Starts With	Enter as much of the title as you know: canadian journal of criminology Omit any initial article (a, an, the, le, la, l', les, etc.): charter of rights in litigation Non-keyword searches automatically truncate to the right when abbreviated: law and psychiat finds all titles that start with this phrase
Author Browse	Enter last name followed by first name or initial: sopinka john fridman g Use normal word order for organizations and groups: law commission of canada canada dept of justice advocacy conference

STEPS

- Library inventory
- Update local notes
- Update bound volumes in holdings
- Install serials module
- Training
- Start using serials module to check-in

WHAT YOU CAN DO BEFORE THE SERIALS MODULE INSTALLATION

- Library inventory
- Make sure the local notes for your subscriptions are up to date

BENEFITS OF SERIALS MODULE

- You can receive, check-in, describe and manage your library's serials through the system. You can:
 - ◆ Predict the receipt schedule of a subscription
 - ◆ Create routing lists
 - ◆ Receive, check-in and describe serials
 - ◆ Retrieve historical info such as: history of received issues, history of claims and problems
- Collection development
